On 11 July 2019, Fincraft Resources Joint Stock Company entered into a sale and purchase deed relating to the transfer of the issued share capital of Fincraft Holdings Ltd to Limited Liability Company Research And Production Association Altair, a limited liability company incorporated in the Russian Federation with number 1107746945646. The transfer of the shares in Fincraft Holdings Ltd from Fincraft Resources Joint Stock Company to Limited Liability Company Research And Production Association Altair completed on 29 July 2019 following satisfaction of certain conditions. Fincraft Holdings Ltd is and remains the holder of 440,565,485 ordinary shares in Petropavlovsk Plc and 8.25% Guaranteed Convertible Bonds 2024 (equating to 210,370,370 additional voting rights).
